Late pick-up

(after 6:00PM) will result in a late fee of \$2.00 per minute. This will be paid directly to the teacher on duty at the time of pick-up

Rate Changes

A tuition increase of approximately 10% will be applied on a per annum basis

Registration Fee

A one time, non-refundable registration fee of \$100, and half the tuition for one month is payable at the time this agreement is signed and returned. The second half of the payment is due on the child's first day of school.

Frequency of Payments

Payment is due during the first five days of each month. A late charge of \$15 is applied for any late payment. A charge of \$15 will be added to your account for each check returned by your bank.

Illness

There will be no refund for absence due to illness. In case of a protracted illness, two weeks tuition will be charged to maintain attendance. Children who are sick should not attend school for 24 hours after symptoms have ceased. Children should remain home until they feel well enough to participate in normal social activities.

Transfers

Children will advance to the next grade based on their physical, emotional and intellectual achievement. A child's age in one of many factors that will be considered in determining their readiness. The staff at the school will notify the parents when their child is ready to move to the next grade.

Withdrawal

In case of withdrawal, four weeks notice is required. Payment in full is due at the time the notice is given. The tuition for children enrolled in the Pre-K classes will include the full month of August before leaving for Kindergarten.
